**THERMA-TRU DOORS DEALER "UGLY DOOR" PROMOTION  
OFFICIAL RULES**

1. This promotion is open to any dealer of Therma-Tru Doors in the 50 United States, D.C, or Ontario, Canada that is in good standing (the "Dealer"). The Therma-Tru Doors Dealer "Ugliest Door" Promotion (the "Promotion"), sponsored by Therma-Tru Corp. (the "Sponsor"), begins on May 3, 2010 at 12:00:01 a.m. Eastern Time ("ET") and ends on July 2, 2010 at 11:59:59 p.m. ET (the "Promotion Period"), by which time all online entries into Therma-Tru's Ugliest Door Contest (the "Contest") including the name of the Dealer through which the entrant learned of the Contest ("Designated Dealer") must be received; mail-in entry deadlines for entries into the Contest including the name of the Designated Dealer must be post marked by July 2, 2010, and received by July 9, 2010. The computer clock of Sponsor's webmaster is the official timekeeping device of the Promotion. The prize will be awarded to the authorized representative of Dealer in accordance with these Rules.
2. The winning Dealer will be the Dealer that during the Promotion Period is named the Designated Dealer most often by eligible Contest entrants, regardless of entry method ("Winner"). Tallying of Designated Dealers will be conducted by Sponsor on or about July 16, 2010, in Maumee, OH and decisions of Sponsor will be final on all matters relating to this Promotion. In the case of a tie involving a Dealer(s) located outside the State of Wisconsin, then the Winner will be selected based upon a random drawing conducted by Sponsor on or about July 16, 2010, in Maumee, OH. In the case of a tie involving a Dealer(s) located in Wisconsin, all tied Wisconsin Dealers will be deemed a "Winner". Winner will be notified by mail and/or e-mail on or about July 19, 2010. Odds of winning depend upon the number of eligible entrants to the Contest that name the Dealer as Designated Dealer. Sponsor is unaware of how many eligible Contest entrants will designate any Dealer as Designated Dealer. If, in Sponsor's opinion, there is any suspected or actual evidence that the integrity of the Contest or this Promotion has been compromised, Sponsor reserves the right to terminate the Promotion and conduct a random drawing to award the prize from amongst all eligible Dealer's named by eligible Contest entrants, using all eligible Contest entries received as of the termination date. Should the Promotion be terminated prior to the stated expiration date, notice will be posted at [www.myuglydoor.com](http://www.myuglydoor.com). Sponsor also reserves the right, in its sole discretion, to cancel the Promotion upon posting of a termination notice at [www.myuglydoor.com](http://www.myuglydoor.com), in the event an insufficient number of Dealers are designated by eligible Contest entrants.
3. One Dealer will be deemed the Winner and will receive a Five Hundred Dollar (\$500) check (ARV \$500). Dollar amounts are expressed in U.S. currency. The prize is non-transferable, and no prize substitutions or cash redemptions are allowed except by Sponsor in its sole discretion. All taxes on the prize are the Winner's sole responsibility. The prize will be awarded according to these Rules and distributed no later than September 1, 2010.

Winner will be required to attest good standing, and sign and return a Publicity Release without additional compensation (where permitted by law) within 14 days of Sponsor's initial notification attempt, which will be made within 5 days from the tallying of Designated Dealers, or the prize will be forfeited and awarded to an alternate Winner, time permitting. If the Winner is from Ontario, the Winner will be required to answer, without mechanical or other assistance, a mathematical skill-testing question posed via telephone at a pre-arranged, mutually convenient time as a prerequisite to being declared the Winner.
